

## Addendum to the Power of Attorney

I/We authorise **GOLDMINE** to apply for various products like Mutual Funds, Public Issues (shares as well as debentures), rights, offer of shares, tendering shares in open offers etc. pursuant to oral/written/electronic instructions given by me/us.

I/We authorize **GOLDMINE** to pledge the securities in favor of the **GOLDMINE** for the limited purpose of meeting my/our margin requirements in connection with the trades executed by me/us on any recognized stock exchange through **GOLDMINE**. Further **GOLDMINE** may re-pledge such securities to the exchange/clearing corporation/clearing member as the case may be for the purpose of my/our margin requirements in connection with the trades executed by me/us on any recognized stock exchange through the **GOLDMINE**.
